**Subject: Urgent Action Needed to End Israel's Genocide in Gaza**

Dear [Name of Foreign Minister / Government Official/ Representative],

I am writing to you as a deeply concerned [citizen/resident] of [Country], urging your government to take immediate and meaningful action to bring an end to Israel's genocide in Gaza.

The situation is catastrophic. Israel is deliberately starving over two million Palestinians, using hunger as a weapon of war. In May 2025, the Palestinian Prime Minister declared Gaza a 'famine zone'.

A third of Gaza's hospitals have been completely shut down, and many more have been bombed or forced to cease operations due to a lack of fuel, medicines, and safe access. Patients, including children, have been forcibly evacuated or left to die in the rubble. Healthcare workers - some of the last remaining lifelines for Palestinians – have been abducted, detained, and over a thousand of them killed.

This is not happening in isolation. These actions are part of a broader pattern of violations of international humanitarian law, including what many UN experts and international human rights organisations have concluded is the extermination and genocide of the Palestinian people. In January 2024, the International Court of Justice – the highest court

in the world – ruled that there is a plausible risk of genocide taking place in Gaza and that states are legally obligated to act

And yet, these atrocities continue to be made possible because of the ongoing impunity granted to Israel - not least through continued arms transfers, diplomatic cover, and the failure of states like [insert your country] to take meaningful action to hold all perpetrators of violations accountable.

It is imperative that your government:

Immediately suspend all arms transfers to Israel, including any components, technology, or military cooperation that may contribute to the ongoing assault on Gaza.

Support full accountability for all violations of international law – including through public support for the International Criminal Court’s arrest warrants – and take meaningful legal, diplomatic, and economic action to end Israel’s impunity.

Take all possible steps to end Israel’s unlawful occupation of Palestinian territory, in line with the 2024 advisory opinion of the International Court of Justice, which reaffirmed the illegality of Israel’s prolonged occupation.

As a [citizen/resident] of [Country], I call on our government to uphold international law consistently — not selectively. This includes protecting civilians, defending the right to health, and refusing to be complicit in war crimes or crimes against humanity.

Every second without action costs lives. The international community must no longer remain silent or idle in the face of such grave violations.

I urge you to act now, and I look forward to your response.
